Our China office includes a merchandising and development team as well as a specialized sample section for knit fabrics. We also have a complete in-house fabric development department in Bangladesh, enabling us to manage the full process—from knitting to dyeing to finishing—for any fabrics that can be developed locally. For fabrics that cannot be sourced or developed in Bangladesh, we carry out the development process through our China office.

#### The Audit Committee

#### Risk Management

#### **Sustainability Report**

#### 1. Energy Efficiency

#### **Current Initiatives:**

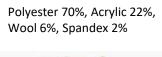

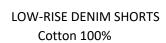

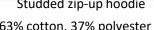
